Your Local 37 Bargaining Committee is pleased to announce that it has reached a tentative agreement with the City of Calgary for the renewal of your Collective Agreement.

Monetary Highlights:

- > 2024 3% Pay Increase
- > 2025 3.25% Pay Increase
- > 2026 3.25% Pay Increase
- ➤ Boot Allowance Increase to \$250.00 for Permanent Employees Boot Allowance Increase to \$100.00 for Seasonal Employees Boot Allowances are No Longer Taxable
- New Premium Swimsuit Allowance for all Aquatic Employees
- Shift Differential Increase
- Re-Worked Recall Language from a Monthly to an Hour Worked Requirement

 Wednesday, July 3, 2024, or Thursday, July 4, 2024, at the CUPE Local 37 Hall, located at 5112 3rd Street SE, Calgary; park at the back and enter through the back door (ring the buzzer). Voting in person is open from 7:00 AM until 4:30 PM on both days.

- If you are planning on voting electronically, please note that you MUST call or email the Local 37 Office and provide a personal email address (we cannot under any circumstances use a City of Calgary email address). You must also ensure that you add vote@simplyvoting.com to your safe-senders list to ensure the delivery of the email. If your personal email address is part of a large number of email addresses, you should request from your Internet provider or IT service desk that any emails from Simply Voting be white-listed.
